REQUIREMENTS TO OBTAIN A TURKS AND CAICOS VISITOR'S VISA

- 1. Application form (fully completed)
- 2. Photos (2) (must be certified by a justice of the peace)
- 3. Current police record from the country of origin (must be translated if not in English)
- 4. Job letter (if self-employed proof of company business licence).
- 5. Applicant's passport (must be valid six months prior to the expiration date)
- 6. Copy of the surety's identification (must be certified) and original bank reference letter on the surety's behalf
- 7. Copy of the consultant's current business licence and identification
- 8. Cover letter from surety applying for a visa on behalf of the applicant
- 9. Evidence of surety legal status in the Turks and Caicos Islands
- 10. Proof of vaccination for applicants over the age of 12
- 11. Administrative fee (\$100.00) non-refundable)
- 12. Upon approval an additional payment of (\$150.00)
- 13. Any person submitting a visa application who does not meet the above requirement his/her application may not be processed

NB. The Immigration Ordinance (2021) Regulation (9) (2) states that an application for a visa shall be made from outside the Islands— to the nearest British High Commission, Embassy or Consulate; to the Director of Immigration, Grand Turk; or to the Turks and Caicos Islands representative at the Turks and Caicos Islands office in London, England, or New York, United States of America.

The Director of Immigration may grant or decline a visa application under his statutory powers.
