CONDITIONS FOR COLLECTING NATIONAL TURKS AND CAICOS ISLANDER STATUS CARDS

Please note that applicants who are 18 years of age and over are expected to appear in person to receive their Card. If the applicant cannot appear in person and would like to have someone collect his Card, this person must have **a typed and signed letter of consent** from the applicant allowing him to collect the Card as well as a valid picture ID for verification.

In the case of persons under the age of 18, either parent of the child is required to appear in person to receive the child's Card. (Bring along a valid picture ID!) Any other person, who is not the parent of the child, is required to produce **a typed and signed letter of consent** from the mother or father along with a valid picture ID, to collect the child's Card.

All consent letters must be typed on a plain sheet of 8.5" X 11" sized paper. A consent letter should include the date, applicant's name, the collector's name, and the applicant's signature. The National Turks and Caicos Islander Status Card may not be released if the applicant fails to comply.

National Turks and Caicos Islander Status Cards cannot be mailed nor can they be collected by anyone under the age of eighteen.
