*Please note that a computerised image is not acceptable – this must be a genuine passport photo.

() Certified copy of Birth certificate (if not in English, must be accompanied by a translated copy into English, signed by the translator and certified by a Justice of the Peace or Notary Public)

() Police certificate (proving good character and issued in the last 6 months)

() Certified copy of Applicant’s ID page of passport (photo page)

() Certified copy of Marriage certificate

() Certified copy of spouse’s ID page of passport (photo page)

() Treasury receipt for sum paid on submission of application.

() Certified birth certificate of dependant children and proof of their residency in the Islands.

Evidence you have been residing in the islands for at least 2 years at the date of the application
