## **REQUIREMENTS TO OBTAIN A MARRIAGE LICENCE IN THE TCI**

- (1) PHOTO IDENTIFICATION / PASSPORT ID
- (2) *BIRTH CERTIFICATE*
- (3) A CERTIFICATE OF NO-IMPEDIMENT FROM THE REGISTRY, COUNTRY/ STATE WHERE YOU RESIDE
- (4) AFFIDAVIT OF SINGLE STATUS (Office will provide form)
- (5) *DIVORCE DECREE*
- (6) DEATH CERTIFICATE (If widow or widower) and, copy of Marriage Certificate verifying the marriage between the deceased Spouse and Declarant.
- (7) TWO (2) DECLARATION *FORMS* (See attached to application form)
- (8) COPY OF TCI IMMIGRATION ARRIVAL AND DEPARTURE STAMP
- (9) PERSONS UNDER THE AGE OF 21 YEARS **MUST** HAVE CONSENT FROM PARENT OR GUARDIAN
- (10) APPLICATION FEE - \$150.00
- (11) VISITORS OR TOURIST **MUST** BE IN THE TURKS & CAICOS 48 HOURS **BEFORE** SUBMITTING APPLICATION
- (12) ALL COPIES OF DOCUMENTS **MUST** BE NOTARIZED AND SEALED
